World Day of Architecture



World Day of Architecture is celebrated worldwide on the first Monday of October. This year is the 2nd year PAM is celebrating this special occasion. Last year PAM organised an exhibition at PAM Centre to mark the occasion and I was personally involved in the organising of this exhibition but unfortunately was not able to attend the officiating ceremony as I was recuperating at St. Vincent Hospital, Melbourne, Australia.

This year the theme is 'Architecture and Human Rights'. The theme invites reflection and action and raises a series of questions on the part of architects worldwide.

'Human Rights' covers a wide spectrum and one such area that is often forgotten is the basic human right to have access to a shelter or a home.

As architects, we are obligated to look into the matter. We must work on this issue at all levels. In our country today, housing and house ownership are still issues that need national focus.

The government has come up with the National Housing Policy and PR1MA (Perumahan Rakyat 1 Malaysia) but unfortunately the professionals' roles including those of the architect's are not defined clearly. PR1MA's objective is to look into providing affordable housing which does not necessarily mean low-cost housing. PAM will look further into the matter to seriously address this.

Issues on affordable housing are always being debated. Who should be looking into it, the government or private sectors? Is the price right? Is the built up area sufficient? And so forth.

In terms of design and space requirement, PAM can assist the government and the relevant bodies to organise a competition to identify the best solution.

PAM can even work or collaborate with other bodies such as CIDB and Jabatan Perumahan Negara to establish building designs using the IBS system. If proven successful, this will spur the production of IBS components nationwide and encourage its acceptance as a component of the Green Building requirement.

PAM as the national institute for architects shall support and assist the government and all related bodies to help resolve these issues on housing since it is the basic right of every individual to own and have a shelter.

WORLD DAY OF ARCHITECTURE

The first Monday of October each year is World Architecture Day, as sanctioned by the International Union of Architects (UIA); with the aim of promoting good architecture, raising public awareness about the role of architects and architectural firms in the locality and to serve as a meeting point for members and potential members.

To celebrate World Architecture Day 2011, with the theme "Architecture and Human Rights", the national PAM Secretariat in Kuala Lumpur, PAM Southern Chapter and PAM Sarawak Chapter respectively organised architectural installations at selected public spaces in their respective cities.

In Kuala Lumpur, the "World Day of Architecture" opening ceremony was held on 3 October 2011 at PAM Centre, Kuala Lumpur and officiated by Dato' Sri Ar Haji Esa Mohamed, UIA Vice President Region IV. There were three sculptures displayed from 3 to 18 October 2011, constructed by 21 students from International Islamic University Malaysia, University Putra Malaysia, University Teknologi MARA, International University College Twintech, Kuala Lumpur University Metropolitan College and Tunku Abdul Rahman College.

Louise Cox, UIA President 2008-2011, addressed a message to the architects of the world for the 2011 WDA:

"Retention of dignity is essential to a healthy city. We must not forget people nor lose sight of their universal rights."

"The architects must work on this issue at community and local government levels as well as on the level of large city governments. Through its programme Action without Borders, the UIA is orienting its actions and reflections towards these issues." In Johor Bahru, the PAM Southern Chapter's architectural installation was located at Plaza Art Align Johor Bahru, Johor and officiated by Tuan Haji Ismail bin Haji Abdul Rahman, Secretary of Johor Bahru City Council. The PAM Southern Chapter, in collaboration with final year students from UTM's Faculty of Built Environment, organised the construction of the sculpture with the concept of "Sculpture for People".

In Kuching, PAM Sarawak Chapter commissioned an architectural installation named "Cardboard City" at the The Spring. For a week, the 6 x 9 x 4 metre high structure doubled as an exhibition space for PAM activities and architectural projects. The architectural installation aimed to prompt discussion and dialogue about the basic Human Right to Housing and an Adequate Standard of Living providing decent housing for all and how this may be achieved by 'thinking outside the box' through architecture and design. The installation is built by volunteers – many of whom are architecture students. PAM Southern Chapter believes that this is an important experience for students of architecture; to build with their hands as well as their minds.

PAM ANNUAL ARCHITECTURE STUDENTS WORKS EXHIBITION 2011

2-9 October 2011, 1 Utama Shopping Centre, Bandar Utama, Petaling Jaya

PAM Education committee organised the 6th PAM Annual Architecture Student Works Exhibition at One Utama Shopping Center, Bandar Utama Petaling Jaya, Selangor from 02-09 October 2011, with the objective of instilling public awareness and appreciation of architecture.

The theme for this year's exhibition was "Underwater Environment" showcasing the excellent works of students from the public universities and private institutes in Malaysia. The opening ceremony was officiated by Ar Tan Pei Ing in her capacity as ARCASIA President-Elect. The exhibition displayed a total of 17 booths.

The Best Display Booth Awards were given out to the top 3 best displays. The winners were Taylors University 1st place, Politeknik Sultan Haji Ahmad Shah, 2nd Place and Universiti Teknologi Malaysia, Skudai, 3rd place.

In conjunction with the exhibition, the Committee organised "The Equilibrium Balance Competition", on 8 October 2011. The competition was opened to all architectural students from the universities and institutes participating in the exhibition. A total of 7 groups with 5 students per team entered the competition. The winners were Group C Kolej Kemahiran Tinggi MARA, Pasir Mas Kelantan and Group E from Kolej Kemahiran Tinggi MARA, Pasir Mas Kelantan won second place. Group A from International University College Technology Twintech took 3rd place.

During the exhibition, a children competition, Bausack 3D Tower Construction Competition, was also organised with the aim to expose the students to architecture. A total of 71 children participated in the competition for two days. Those who could construct the tallest tower were declared as winners receiving prizes and certificates, while other participants were given consolation prizes.

PAM also encouraged all participating schools of architecture to hold their activities to attract visitors to the exhibition. Dancing and singing concert was performed by Politeknik Port Dickson, musical chair games by City University College of Science & Technology and Kolej Kemahiran Tinggi MARA, Pasir Mas and puzzle /telematch games by ALFA International College.

During the closing ceremony, PAM gave out awards and appreciation certificates to architectural students and schoosl for their achievements throughout the exhibition. The list of awards and certificate include Certificate for PAM Student Volunteer Program, PAM Best Academic Awards 2011, PAM-CIS Best Student Award 2011, Certificate for Participating School and PAM Best Display Booth Awards 2011.

A TRIBUTE TO AN ARCHITECT

FRANK LING FAH SHING, the architect who stayed true to his professional calling to do the best design he could in a challenging environment, passed away on 11th October 2011 in Kota Kinabalu. He was 52.

His wife Ivy said Fahshing died peacefully at home after battling cancer for the past year.

Born in 1959 in Kota Kinabalu, Sabah, Malaysia, Fahshing attended Chung Hwa Primary School and All Saints Secondary School, where he obtained Higher School Certificate ('A' level) in 1979.

As fate had it that his older brother Ar. Lam Choi Sing who graduated with a degree in Architecture from the University of Oregon, USA in 1976 showed him a book that changed his life. "The Master Builders" featuring Frank Lloyd Wright, Le Corbusier and Mies Van Der Rohe sparked the fire in Fahshing which he believed being an Architect was how he was going to make a difference.

He did one year at his brother's alma mater before completed his bachelor degree in Architecture in 1985 at Arizona State University, USA. After graduation, Fahshing did his practical training in Arizona and California. He passed the NCARB, USA licensing exam and was a Registered Architect in the State of California.

He returned to Kota Kinabalu, Malaysia in 1990 and worked at Akitek Design Group prior to passing PAM/LAM Part 3 exam in 1993. He was one of the founding partners in Teamconcept Architects before coming out solo to establish Fahshing Architect in 2001.

Fahshing's architectural education and experience in the U.S. strongly influenced his desire to pursue the highest quality of design. He was a man of many interests: from psychology to astrology, and philosophy to nature, and these in turn have fueled his approach to his art. His modern idols include Renzo Piano and tech innovator genius Steve Jobs. Fahshing had always believed that design is in everything that we do and use.

One of his pet projects that reflected his sense of playfulness in design is the Sabah PAM Chapter office. He named the conference room "Centre of Egg-cellence", a reference to the egg shape that he had used. The conference table was designed by using small strips of teak wood on solid glass stands which highlighted the 'delicate' nature of the space.

Fahshing's love of his hometown was demonstrated in a low profile but socially important project: the Gaya Street Renewal Project, which was funded by the Danish government. He understood the importance of the integration between people, vehicular traffic and landscapes, he designed and executed these elements to coexist harmoniously. It is now the most popular street in the State of Sabah where one can feel the historical and cultural heritage of Sabah.

Fahshing was an active member of PAM as he believed architects have a professional and social responsibility in society. He was the Chairman of PAM Sabah Chapter 2001 to 2003. While performing the Chairman role, he was inspired by Dr. Ken Yeang to develop his architectural philosophy by writing a book. Architects often like cliché and Fahshing's very own is "to grow a house". The book "archiNature & a house in Borneo", co-authored by Fahshing, was published in 2003.

One of the notable projects by Fahshing is "Sinurambi", or "a jungle hut" in the local Kadazan language. In the project and the book "archiNature", he realized his destiny to be an equal with the architects of international standing. The house was featured in the book "25 Tropical Houses in Singapore and Malaysia" by Paul McGillick, published in 2006.
